## **HOW ARE TAXES PAID?**

If your bank or mortgage company pays taxes for you, <u>please</u> contact them, or forward this bill to them.

If you are <u>not responsible</u> for payment of this bill, forward to the owner or return it to our office.

Both installments may be paid on or before the due date of the <u>first installment</u> or pay each installment on our before the due date shown.

Late payments received without the penalty included will be returned.

If payment is late, Illinois law requires a 1  $\frac{1}{2}$ % interest penalty per month. Parts or fractions of a 30 day period are regarded as 30 days. To avoid this penalty you must pay on or before the due date.

Failure to receive a tax bill or receiving it late, for any reason, will not relieve tax payer from paying taxes or late penalties.

## **OPTIONS FOR PAYING YOUR PROPERTY TAXES**

**At your bank**: All of the banks in Boone County accept property tax payments on our behalf.

**By mail**: Send your check with the payment stub to the Boone County Treasurer at the address above. Your payment must be postmarked on or before the due date.

Online bill pay: If your bank offers online bill payment, enter your property number as the vendor account number so we can properly record your payment. We cannot be responsible for payments received with no property number reference.

Online by credit or debit card through Illinois E-Pay: Go to http://illinoisepay.com and type Boone County Treasurer in the search box. This service is offered through the Illinois State Treasurer's Office and they charge a convenience fee that varies according to the type of card and dollar amount. We cannot accept credit/debit cards in our office or by phone.

**At our office** in the Boone County Administration Campus (cash, check, cashier's check or money order). Office hours are 8:30 - 5:00 Monday - Friday.

**Drop box**: If you can't make it to our office by closing time, just drop your payment in the envelope depository at the side door of the Boone County Administration Campus Building. Please use an envelope and include the payment stub.

Note: When paying in person at your bank or our office, <u>bring</u> <u>your entire bill</u> if you want it stamped to show proof of payment.
